

## Pet Policy

**This policy applies on all RAC Parks & Resorts where pets are permitted.**

**A maximum of two pets are permitted per site.**

**Please take the time to read our Pet Policy and sign below.**

Please be aware that at RAC Exmouth Cape Holiday Park and RAC Monkey Mia Dolphin Resort, wild emus do roam the property and they can be aggressive towards small animals.

- » Guests may bring their pets onto RAC Parks & Resorts where permitted at their own risk.
- » Pets must be up-to-date on all vaccinations.
- » Pets are not allowed in any part of the property unless designated as a Pet zone. This especially applies to the playground, areas in which food and beverage are consumed, camp kitchen, barbecue areas, swimming pool and accommodation including the office. This exclusion does not apply to service animals.
- » Pets must be well mannered and appropriately restrained by the Guest at all times.
- » Pets must not be left unattended at any time.
- » Guests are responsible for cleaning up after their pet on the property and in the neighbourhood.
- » Any ongoing disturbances that affect guests' experience, such as barking, may result in termination of your further stay and forfeiture of all monies paid for your stay at RAC Parks & Resorts.

If an RAC property manager reasonably considers that your pet acts in any way considered to be aggressive, dangerous or destructive, RAC's property manager reserves the right to ask you to vacate the property and terminate your stay, in which case you will not be entitled to any refund of monies paid for your stay at RAC Parks & Resorts.

Guests are liable for all loss and damage, including property damage and/or personal injuries, which occurs directly or indirectly resulting from their pet. RAC reserves the right to apply all fees and expenses associated with any such loss and damage to the Guest's account.

To the maximum extent permitted by law, RAC will not be held responsible or liable whether in negligence, contract or otherwise if any person incurs, experiences or suffers any direct or indirect loss (including but not limited to any loss suffered to property or person and economic loss),

damage, fatality, injury (including psychological trauma), inconvenience or health related issue whatsoever arising out of or connected to your pet.

You fully and finally release and discharge RAC from any liability, claim, action, right, entitlement, expense or cost that you may have or incur arising out of the conduct, acts or omissions of your pet during or connected to your stay at RAC Parks & Resorts.
